Strategy

Efficient Implementation: The portfolio consists of 11 global equity sector ETFs, across developed markets, which are controlled individually. The assets, which are not allocated into equities are kept in a money market ETF basket.

Drawdowns: The aim is to minimize market losses through dynamic exposure management (0-100%).





ETP+ uses not only a reputable custodian and collateral agent, both based in Switzerland, but also provides for daily independent checks, which serve as key mitigators of the issuer risk. In combination with Leonteq as an issuer that is a regulated securities firm with an investment grade rating and a strong capital position, this new setup offers a compelling differentiation to existing ETP providers.

Collateralization to safeguard investor interests

Leonteq is partnering with SIX to reduce issuer credit risk and to protect ETP+ investors' interests by collateralizing any ETP+ liabilities over the product lifecycle.

Under this arrangement, collateral is held at SIX SIS AG, and SIX Repo AG, in its function as collateral agent, is responsible for daily inspections of the collateral. The collateralization technique used for ETP+ is based on an established framework with SIX that has been in place since 2012
